SUMMARY

- The Offer Price has been determined at HK\$0.52 per Offer Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.52 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commissions and other estimated expenses payable by the Company and assuming no exercise of Over-allotment Option, is estimated to be approximately HK\$107 million.
- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 12,488 valid applications were received for a total of 1,159,868,000 Public Offer Shares, equivalent to approximately 46.39 times of the total number of 25,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- As the over-subscription in the Public Offer represents 15 times or more but less than 50 times of the number of Offer Shares initially available under the Public Offer, 50,000,000 Offer Shares will be reallocated to the Public Offer from the Placing, increasing the total number of Offer Shares available under the Public Offer to 75,000,000, representing 30% of the Offer Shares initially available under the Share Offer. The Offer Shares offered in the Public Offer were conditionally allocated on the basis set out in the paragraph headed “Basis of Allocation under the Public Offer” below.
